## Fall 2017 Cost of Attendance Analysis

Based on Financial Aid Award Offers to

Full-Time First Bachelor Degree-Seeking Students Attending at the Resident/Reciprocity Tuition Rate

In fall 2017, 98% of First-Time in College<sup>1</sup> and 91% of Undergraduate<sup>2</sup> students were awarded scholarship<sup>3</sup>, grant, and/or loan aid.

- 1. First-Time in College constitutes the GRS (Graduation Rate Survey) cohort which is used to calculate the six-year graduation rate. First-Time in College students includes those who earned precollege credit and entered at the sophomore classification.
- 2. Undergraduates, which includes First-Time in College, constitutes first bachelor degree-seeking students (freshman, sophomore, junior, senior). Post-baccalaureate students were excluded.
- 3. Scholarships include both merit and need-based scholarships.
- 4. Fall 2017 direct costs include published tuition amount of \$5,534, the minimum on-campus housing rate and meal plan of \$4,350, an estimate of \$600 for books (source: Student Financial Aid Office). Minimum published tuition of \$5,534 differs from the average tuition and fees of \$5,845. The average tuition and fees of \$5,845 is calculated using an average of the meal plans, average of on-campus housing, and books and fees. This average differs from the direct costs amount calculated by using the minimum tuition, minimum meal plan, and minimum on-campus housing rates possible.

- 6. Data provided are based upon financial aid award offers and not actual disbursements. Offered award amounts that are estimated may differ from disbursed amounts. Financial aid earned in biweekly paychecks by students working in the Federal Work-Study program were excluded from this analysis.
